- + Water supply: access to 2 high-production water wells and reservoir

- + Frost protection:
 - o Overhead sprinklers from pond
 - o One wind machine
- + Large staging area for harvest equipment

 - o 8312: 5 bedrooms, 3 baths, 3216 +/- sq ft, renovated, tenant occupied, \$4700/month rental income
 - o 8314: 3 bedrooms, 1 bath, 1225 +/- sq ft, renovated, tenant occupied, \$3,175/month rental income
 - o 8316: 3 bedrooms, 1 bath, 945 +/- sq ft, needs to be renovated, not occupied, \$3,000/month estimated rental income
 - o 8318: Manufactured home, 3 bedrooms, 2 baths, 1702 +/- sq ft, renovated, occupied by caretaker for free, \$3800/month approximate market rate rent

INFRASTRUCTURE

- + Water:
 - o Ag well with production 350 gpm tested in July 2021
 - o Domestic well with production of 85 gpm tested in August, 2022
- + Wells shared with 8320 Franz Valley
- + Domestic well also shared with neighbor
- + Standard septic systems for rental cottages
- + Fuel tanks: above ground diesel and unleaded gas tanks
- + Propane: 6 tanks, (1 wind machine, 1 for each rental, 1 at barn)
